Rationale

Overview

On January 27, 2020 the Board of Trustees received the Long-Term Accommodation Plan 2020-2024 (LTAP) report and approved the guiding principles and actions to be undertaken. Within the LTAP report, staff was directed to undertake a French Immersion (FI) Study in Brooklin to combine the St. Leo Catholic School and St. John Paul II Catholic School programs.

A previous update was provided to the Board of Trustees on April 15, 2020 that outlined the steps taken up until March 12, 2020. This report provides the Board of Trustees with an update and next steps given the current situation around COVID-19 and school closures.

This report specifically recommends that:

- The Board reschedule the three remaining committee meetings and the two remaining public meetings for the fall of 2020, pending the lifting of current restrictions on public gatherings
- Develop a recommended future location of the Brooklin FI program by an ammended date of November 2020.

Update

Since the start of the Brooklin FI Study, established on January 27, 2020, two committee meetings and one public meeting has been held. The Ministry of Education had ordered school closures effective March 14, 2020 due to the emergence of COVID-19 in Ontario. The original two week closure following the March Break has since been extended until May 3, 2020.
