- 2.2. Presentations
  - 2.2.1. Voluntary Student Census Margaret Brimpong

Margaret Brimpong, Senior Manager of Equity, Anti-Racism and Engagement, presented the Stand Up, Be Counted, Be Heard Student Census; a voluntary survey that offers students an opportunity to self-identify various aspects of their identity.

Ms. Brimpong shared that the Ministry of Education is supporting school boards to build capacity to collect, analyze, and use voluntary students and workforce demographics data to promote inclusive and equitable work cultures and learning environments, meet the responsibilities to protect and uphold human rights under the Ontario Human Rights Code, and meet their obligations under the Data Standards for the Identification and Monitoring of Systemic Racism.

Students in Grades 6-12 will be asked to complete the voluntary student census from April 25-29, 2022. Ms. Brimpong informed that the Student Census will collect quality and confidential student demographic data that will enable evidence-based decision making, while helping to address barriers to student success.

Ms. Brimpong added that the goal of Student Census is to understand and support the diversity of students and families, eliminate barriers to student success, and enrich students' learning Special Education Advisory Committee Meeting October 5, 2021 Page 3 of 8

by providing the right supports at the right time while making schools safer and more welcoming for all. The data obtained from the student census will allow the board to make evidence-informed decisions with respect to the identification and elimination of systemic barriers and establish organizational improvement goals for school communities.

2.5.1. Coordinator's Report - Christine Congrady

•Durham Catholic Autism Resource Team (DCART) has a second Board Certified Behaviour Analyst (BCBA), Michelle Adair. Michelle will be supporting other students with behavioural needs, including students who are being supported by the Behaviour Resource Team (BRT).

## 2.5.2. Mental Health Leader's Report - Shelley Phoenix

On September 28th, 86 Intermediate teachers from DCDSB, DDSB and KPRDSB attended a joint (3 boards) teacher training session to provide them with guidance and direction in order for them to run the TAMI classroom program in their classrooms this year. This year, rather than bringing facilitators and speakers with lived experience into schools, the program will be running virtually. We have created, and will be providing teachers with video content for portions of the program and demonstration videos to help teachers run some of the activities. The speaker portion of the program will also be done virtually with a TAMI coalition member facilitating the session and bringing two pre-recorded speaker videos. We hope to resume in-person speaker sessions when it's possible to do so.

In September, we wrapped up our parent mental health workshop series with Charmaine Laine on Sept 23 (Supporting your Child's

Mental Health Through the Impact of Racism and Oppression) and Nicole Tuzi from Sick Kids Hospital on Sept 28 (From Zoom to Classroom- How to Support Your Child's Social-Emotional Development When Returning to School).

At today's Program Support Teacher's meeting, two of our Behaviour Support Specialists rolled out the self-regulation kits that they created and put-together over the summer. These kits were intentionally developed to support students who have difficulty with self-regulating their behaviour and emotions and each school received their own kit.

DCDSB has partnered with Victim Services of Durham, who has provided training to all Administrators and Gatekeepers on Anti-Human Trafficking. During the PA day on November 12, 2021, all staff will receive similar training. This is in response to PPM 166:Keeping Students Safe: Policy Framework for School Board Anti-Sex Trafficking Protocols. This policy direction by the Ministry recognises the unique role that schools can play in the prevention and intervention in cases of sex trafficking, which is very prevalent in Ontario and in Durham region.

- Staff professional development opportunities in October:
- Many of our professional staff took part in training with School Mental Health Ontario last week on supporting students with eating disorders;
- two safeTALK sessions have been scheduled for EAs on the Oct 8 PD day;
- we are offering Applied Suicide Intervention Skills Training (ASIST) for school staff in a gatekeeper role on October 13 and 14

Superintendent Lee-Fernandes thanked all the DCDSB staff that work in special education and ensure that our students feel welcome, supported and happy.

Superintendent Lee-Fernandes highlighted that October is Learning Disabilities Awareness month and shared how it is being promoted internally across the board and externally to the parent and guardian community through a number of social media platforms.

Superintendent Lee-Fernandes shared updates on Equity and Inclusive Education and provided highlights of the key focus areas under Equity; Anti-Black, Anti-Discrimination and Culturally Responsive and Relevant Pedagogy.

Superintendent Lee-Fernandes highlighted the purpose of the Special Education review and emphasized that the DCDSB wants to ensure that all members within the system work together to provide an inclusive school environment where students with special education needs can thrive and be inspired to reach their full potential, work to remove systemic barriers, and ensure transparent oversight and accountability for the delivery of programs and services to meet student needs as well as continuously strive for excellence through the use of evidence-based programs and approaches to support student learning and achievement.

Superintendent Lee-Fernandes shared the key components and standards of service of the delivery model in Special Education.

New Programs or Services:

Caregiver-mediated early years programs

With Grandview Kids as the lead, Lake Ridge Community Support Services and The Regional Municipality of Durham have begun delivering three caregiver-mediated early years programs as part of the Ontario Autism Program – OAP.

These programs help young children (12 to 48 months of age) learn new skills and meet individualized goals in their natural environments.

The Ministry of Children, Community and Social Services are directly inviting families to participate via written letter. Grandview Kids is overseeing the referral and intake process. Families may only participate in one program at a time at no cost.
