- 2.5.1. Student Service Report Christine Congrady, Yulan Fisher-Brown, Susie Lee-Fernandes
 - C. Congrady shared the following updates:
 - The Student Services Coordinators are currently visiting all schools across the system to review special education needs.
 - On October 18, 2022, both Elementary Term 1 and Secondary Semester 1 IEPs will go home
 - The new PST Mentoring Program resumes October 27, 2022
 - October Sharing of Excellence Series: Two-part series Principles of ABA: Reinforcements
 - Accessibility Services at post-secondary destinations Student Services staff will be available during each secondary school's College or University Fair

Autism:

 Sonderly funding for Geneva Centre online courses has been continued this year, with some new course offerings. A numbered memo will come out in November for participation.
 All educators will be eligible to take the courses.

- Social skills programs resume this month in both in-person and virtual delivery models. Programs offerings include PEERS, Friendship Lab, and Secret Agent Society.
- DCART and BSS staff will be attending the Geneva Centre Symposium through online learning, November 2-4, 2022.

Assistive Technology:

- The 500 Lexia subscriptions (reading intervention program) licenses were renewed again this school year
- Two Lexia refresher workshops took place last week for PSTs that used Lexia previously. These workshops highlighted new features and resources available.
- Lexia training for new Program Support Teachers occurs this week

Y. Fisher-Brown, Mental Health Lead shared the following Mental Health report:

- As mentioned last month, the teacher information session for the Harry Potter and the Prisoner of Azkaban: A Cognitive Behavioural Therapy Novel Study for Intermediate Students took place on September 13th and 19th. Currently, 13 teachers signed up to participate in the study.
- On the September 23rd PD day, Student Services offered a SafeTALK session, with the target audience being EAs- 17 attended.
- Tomorrow, the TAMI teacher training will be offered for the staff of 10 schools that will have the program run in their intermediate classes. The program is available to secondary schools at their request.
- The Roots of Empathy program will begin to run in several schools. We are on the hunt for families with babies younger than 4 months old who would like to volunteer for the program.
- The public-facing Mental Health website is currently being revamped to make it more accessible.

S. Lee-Fernandes, Superintendent of Education provided an indepth overview of the Special Education Review.

The Durham Catholic District School Board embraces a philosophy of inclusion. The purpose of the Special Education Review is to:

- Ensure that all community members have a shared vision and understanding of the Board's special education plan
- Intentional work to recognize and remove systemic barriers
- Transparent oversight and accountability for timely and effective accommodations and modifications to programming and services
- Build capacity in special education knowledge and consistency in the implementation of effective programs and/or services for students with special education needs
