Item I.1 Coordinator's Report-continued

Coordinators' Updates:

Durham Region Health and Social Services Committee has expressed an interest in what school boards are doing in the area of mental health, specifically related to suicide prevention. Diane Mullane, and the Mental Health Leaders from the 3 other Durham boards will be doing a joint presentation for them on Jan 12, 2016.

The Ministry of Education has asked School Mental Health ASSIST to provide leadership related to the mental health of newcomers expected from Syria in the coming months. They've formed a "Newcomer Resource Group," consisting of 25-30 Mental Health Leaders, Superintendents, Chief Psychologists and Chief Social Workers. The purpose is to provide a platform for sharing of materials and resources in support of student mental health and well-being and to co-develop new resources, as needed. Diane and Shelley are both involved with this, and have been collaborating locally with others involved in newcomer settlement, in anticipation of the possibility that we have newcomer families in our system.

On December 15th, Program Support Teachers participated in the *Behavioural Management Systems Practitioner Training Course*. Program Support Teachers learned about strategies that support successfully managing behaviours and result in safe and secure learning environments. Follow-up to the program will be provided at the upcoming January Program Support teacher meeting.

After working closely with the Program Support teachers throughout November and December, the Coordinators submitted their completed Special Incidence Portion (SIP) claims to the Ministry at the end of December 2015.

On December 18, the Student Services department attended a presentation on the Health and Physical Education curriculum. Through discussion and group activities, participants were able to identify how this curriculum aligns and connects to Family Life Education and the Ontario Catholic School Graduate expectations.

<u>Item I.2</u> <u>Superintendent's Report- J. Bowyer</u>

The Superintendent provided additional information about the funding model for SIP (Special Incident Portion) claims and the support of 70-80 students in our system through this funding. The Coordinators and Program Support teachers worked collaboratively through the process of preparing claims and submitting documentation to the Ministry of Education. The process was completed in December.

Superintendent Bowyer welcomed Paul Pulla and Kathy Lefort back as our Trustee representatives on SEAC.

Item I.2 Superintendent's Report-continued

The new DCDSB website was launched January 5. The site contains many new accessibility features as well as a much improved search engine. As well, Senior Administrative Assistants will have access in order to keep it as up to date as possible. SEAC agendas and minutes will be posted monthly on the SEAC page of the site, after they have been approved at the Board meeting.

There have been changes at the Senior Administrative level – Superintendent of Facilities Tim Robins has retired. Superintendent Bob Camozzi has taken his place. Rosemary Leclair is returning to our board as Superintendent of Education.

French Immersion registration is taking place at this time. At the upcoming PST meeting, we will be working with our Program Support teachers to examine accommodations and modifications in a French Immersion program that will make second language learning accessible to all.

Superintendent Bowyer provided a copy of the Director's Annual Report 2014-2105 to each SEAC member for review.

Superintendent Bowyer asked Diane Mullane, Mental Health Leader, to provide the following updates on the upcoming "Parents as Partners" Mental Health night and Mental Health Action Plan:

The poster for the event is ready and was shared with SEAC. Flyers and formal invitations will go out to the system. SEAC members were asked to share the information with their agencies, in church bulletins, and with their communities. An electronic version was also shared through email.

Mental Health Action Plan 2015-2016 – Diane Mullane provided a handout to SEAC members and gave an overview of the priorities for the remaining school year with respect to the promotion of positive mental health, support to staff, students and parents, and plans for communication and collaboration within the Board and community.

Continuing her report, Superintendent Bowyer announced that UOIT, in partnership with DCDSB, is offering Special Education Part 1, which will be facilitated by Helen Killoran, Autism Resource teacher, Student Services.
